Macroeconomic

Macroeconomic Section organized a consultative Workshop on Launching of Vision 2025 and 11th Five years Plan 2013-18 on 19th August, 2013 under the chairmanship of Minister for Planning, Development & Reforms. Planning Commission has kick-started the process of preparation of Vision 2025 and 11th year plan to unlock the immense development potential of the country by making the most of our strengths, acknowledging our weaknesses and planning for a future very different from today. It will primarily aim at secure, prosperous, harmonious, enlightened, healthy and knowledgeable Pakistan. The workshop was attended by the wide spectrum of

society including academia, civil society, business community, public sector and parliamentarians.

The Minister reiterated that Planning Commission wants to make planning process more participatory and inclusive because we are planning for better future of Pakistan and this should be vision of every Pakistani irrespective of party divide. He also mentioned that now it is a proven fact that government's role in economic activity tends to create problems everywhere including US and Europe. The private sector has to lead economic growth for political stability and social cohesion and the role of government should be confined to regulations and facilitation.

Macroeconomic section also coordinated a lecture delivered by Mr. Zhang Xiao-qiang, Vice Chairman, National Development and Reform Commission of China on 28th August, 2013. The lecture was attended by a large number of participants from academia, civil society, business community and public sector. Mr. Zhang highlighted the importance of Pak-China development cooperation and reiterated the Chinese commitment to help Pakistan in its development endeavours. Mr. Zhang also narrated China's journey to success and pointed out the avenues where Pakistan could learn from Chinese experience.

Public Investment Authorization Section

During the reporting period, one meeting each of CDWP and ECNEC were held to minimize the long awaiting development schemes backlog. The priority area remained the energy sector's projects. Detail of meetings is as below:

- A special CDWP meeting was held on 26th August, 2013 under the Chairmanship of Minister for Planning, Development & Reforms / Deputy Chairman, Planning Commission. The forum considered sixteen (16) projects with a total financial outlay of Rs.103.900 billion. Out of these projects, five (5) schemes pertaining to Energy Sector worth of Rs.2959.272 million were approved and eight (8) schemes of Energy Sector with estimated cost of Rs. 100.94 billion were recommended to the Executive Committee of the National Economic Council (ECNEC) for approval being within the competency of the ECNEC.
- The Executive Committee of the National Economic Council (ECNEC) meeting was held on 28th August, 2013 under the Chairmanship of Finance Minister. In this meeting, twenty (20) projects were considered out of which sixteen (16) projects with estimated cost of Rs. 136.2 billion were approved and four (4) were deferred. The approved schemes included 12 projects of Energy Sector, two from Water Resources and one each from IT and Food & Agriculture sectors.

Pakistan Planning and Management Institute

During the month of August, 2013, one (01) training course titled "Results - Based Management (20 - 23 August, 2013)" was conducted by PPMI. This course was designed to provide participants clear understanding and skills of how to develop Result-Based Management processes and practices within their own projects and organizations. It was also rele-

vant to those trying to improve Monitoring and Evaluation (M&E) processes, or supporting partners to develop and implement effective M&E. The main focus was on considering result at the time of Planning, Appraisal and Approval, Monitoring and Evaluation. Fifty One (51) officers of Federal/ Provincial Governments and Public Sector Organizations

participated in this training course. Mr. Muhammad Anwar Hussain Ch, Director General, PPMI thanked the participants for their active participation. Rai Nasir Ali Khan, Chief (Macroeconomic Section), M/o Planning, Development and Reforms, chief guest of the ceremony awarded certificates to the participants.

National Fertilizer Development Centre

Following are the recent major developments / news with respect to fertilizer sector of Pakistan:

- Urea offtake during July, 2013 was 466 thousand tonnes, which increased by 19.8 per cent over July, 2012 (389 thousand tonnes). DAP offtake was 81 thousand tonnes, which registered a decrease of 19.6 per cent as compared to July, 2012 (101 thousand tonnes).
- Total fertilizer nutrient offtake during July, 2013 was about 291 thousand tonnes compared to 271 thousand tonnes of July, 2012, showing an increase of 7.3 per cent. Among nutrients, phosphate offtake decreased by 21.9 percent while nitrogen and potash offtake increased by 15.1 and 51.3 per cent respectively.
- Participated in the meeting of Senate Standing Committee on National Food Security & Research and provided a comparative analysis of fertilizer prices & subsidy situation of Pakistan with India.
- Assisted Ministry of Industries & Production in assessing the opportunity cost of providing natural gas to fertilizer industry vis-à-vis power sector along with estimating the impact of removing the un-budgeted feed stock gas subsidy on manufacturing of urea.

Food & Agriculture
