**Program Objectives:**

**Eligibility criteria:-**

The applicant should:

- Be working for the federal government, local government or related institute involved in administrative affairs of livestock industry and expected to continue in the same field.
- Have three (3) years or more experience in the field.
- Be a university graduate or have an equivalent academic background.
- Be under 45 years of age in principal.
- Be proficient in spoken and written English.
- Be in good health, both physically and mentally, to participate in the program in Japan.
- Not be serving in the military service.
