Subject: PROMOTION OF HYDROPOWER DEVELOPMENT

The undersigned is directed to state that the Japan International Cooperation Agency has offered fully funded training course scheduled to be held in Japan w.e.f 19-5-2015 to 18-6-2015. All concerned Ministries/Departments are requested to send nominations of suitable officers who fulfill the following criteria to the undersigned by 20.02.2015 alongwith three (3) copies of prescribed JICA forms, surety bond, undertaking, CNIC, Passport and FTC proforma

Program Objectives:

- > To prepare some policies or plans contributing to steady promotion of hydropower development
- > To familiarize the inclusive knowledge related to hydropower development obtained in Japan to the home country/organization.

Eligibility criteria:-

The applicant should:

- i. Be responsible for hydropower development and those currently (or expected to be in the near future) posted to the managerial position in the government agencies or electric power utilities which are in charged of the development of hydropower generation.
- ii. Have minimum of 5 years practical experience in the hydropower development
- iii. Be between 30-50 years of age.
- iv. Be a graduate of university or equivalent level (*Preferably in mechanical, electrical and civil engineering as majors*)
- v. Have a sufficient command of spoken and written English.
- vi. Be in good health, both physically and mentally, to participate in the program in Japan.
- vii. Not be serving any form of military.
