OFFICE MEMORANDUM

SUBJECT: BILATERAL SEMINAR ON URBAN PLANNING AND MANAGEMENT FOR PAKISTAN IN 2014 FROM NOVEMBER 20TH TO DECEMBER 10TH, 2014 IN (25 SLOTS)

The undersigned is directed to refer to this Division's letter No. 2(1) EA/China-II/2014 dated 5th March, 2014 and to state that Government of People's Republic of China has offered bilateral Seminar for Superintendent officials of China-Aid -Projects for government officials. Participant's qualification and requirements are as under:-

Eligibility Criteria

- Officers of Director Level (BPS-18/19) from Department most relevant to the training programme.
- Maximum age limit 45 years.
- Be in good health and free from any infectious disease.
- Proficiency in English.
- Consent / NOC of the department concerned
- Passport having minimum validity of six months.

Expenses

The following expenses are to be borne by MOFCOM for the participants:

- Round-trip air tickets and transit allowance.
- Boarding and lodging in China.
- Local transportation fees incurred for all activities arranged by the Chinese organizer.
- Pocket money of 60-80 Yuan RMB per head per day for officials and technicians respectively.

The following expenses are to be borne by the Participants themselves:

- Excessive luggage charges during international and domestic travels.
- Post and telecommunications, passport and visa issuance.
- Buy spectacles, see the dentist, or go to beauty saloon.
- Examination, diagnosis, treatment and medicine of any chronic disease.

2. The following documents mentioned at (i), (ii) and (iii) must be attached with the nomination letter, without these documents the application will not be considered. The documents mentioned at (iv) to (vii) should also be sent to EAD upto 30-09-2014.

- FTC Proforma
- NOC or undertaking by the nominating authority that once nominated the candidate will not be withdrawn after selection.
- Two copies of valid passport.
- Undertaking Form
- Medical (Foreigner Physical Examination Form) (two sets)
- Surety Bond




