Eligibility Criteria

- Be a government/municipality-official or a researcher / an instructor with a Bachelor's degree or higher.
- Have a good command of both spoken and written.
- Be preferably under 40 years.
- Not be a person who has withdrawn from KOICA's scholarship program.
- Have not participated in KOICA's scholarship program or any of the Korean government's scholarship program before (especially in a Master's degree program).

Objectives

- Enhancing understanding of the Korean experience of economic development and economic cooperation.
- Building capacity in the areas of development planning, commercial diplomacy, economic crisis management development cooperation.

Nomination of suitable candidates fulfilling the laid-down eligibility criteria (with all the required documents of check list & eligibility criteria as mentioned above) prescribed by the sponsoring agency duly approved by the competent authority along with the documents may kindly be forwarded to this Division by **April 3, 2015** positively.
