Subject: TRAINING PROGRAM ON CAPACITY DEVELOPMENT FOR TECHNICAL VOCATIONAL TRAINING FROM 24 FEBRUARY - 13 MARCH, 2015 UNDER THE MALAYSIA TECHNICAL COOPERATION PROGRAMME (MTCP) (RE-SCHEDULE FROM 31-MARCH TO 17 APRIL 2015)

The undersigned is directed to say that the Malaysia Technical Cooperation Program (MTCP) will be organizing the fully funded subject training program and has invited one nomination for the said program. The program was earlier scheduled from 24 February to 13 March, 2015 but it has been re-scheduled from 31 March to 17 April, 2015. 2. The eligibility criteria and objectives of the course are as under:

Objectives

- To improve TVET trainers based on needs for the economic growth in MTCP-CPSC countries
- To share information and best practices, promote conducive collaboration and networking amongst Malaysian TVET trainers, and
- To expose the participants on Malaysia's experience in strengthening the existing TVET implementation.

Eligibility Criteria.

- Should be a TVET trainer from government's institutions.
- Should be nominated and obtained approval by their respective govt.
- Should be able to provide a valid passport to the course organizer no later than seven 7 weeks before the course commences for VISA application purposes. The passport provided should be valid for at least six months from the date the course ended.
- Must agree to obtain the visa with reference before entering Malaysia.
- Between 26-50 years of age.
- Should have practical experience of more than three years in the automotive trade.
- Should possess a good command of written and spoken English (A phone interview interview with short listed candidates will be conducted by the embassy of Malaysia before a final decision is made.
- Good health physically and mentally, in order to complete the course (applicants must submit his / her medical certificate in the application form.
- Not to be serving in the military.


