Program Objective:

This program aims at strengthening participants capacity to develop methods in order to improve urban transport planning system

Eligibility criteria:-

The applicants should:

- Be central/local government officers in a city with a population of 500,000 or more, responsible for the formulation/implementation of urban transport planning or urban transport facilities planning
- Have more than 3 years professional experience in urban transport planning and management in principle
- Be Graduate of university or equivalent.
- Be under 40 years of age (in principle)
- Be competent command over English both in written and spoken
- Be in good health, both physically and mentally, to participate in the programme in Japan, Pregnant applicants are not recommended to apply due to the potential risk of health.
