- All English Language Teachers.
- Age between 25-45 Years old.
- Preferred background in TESL/TEFL/TESOL.
- Participants from MTCP participating countries.
- Has not participated in any course under MTCP.
- Proficient in spoken and written English.
- Medically fit to attend the course.
