3. The bidders must bring their original CNIC and provide complete address/telephone numbers and attested copy of CNIC on the day of auction.
4. Vehicles will be sold only when the highest bid exceeds the reserve price.
5. All bidders will be required to deposit Rs.100,000/- (refundable) along with a copy of CNIC as token money to participate in the bid.
6. If for any reason the office is closed on auction day, the auction will be held on the next working day at the same place and time.
7. Successful bidder must deposit earnest money i.e. 25% of the bid in cash on spot and balance amount of the bid, within 10 days of the auction, otherwise earnest money (25% of the bid) will be forfeited in favour of the Government.
