The undersigned is directed to inform that the Government of Singapore has invited One (01) nomination for the above **Partially Funded** training course from 6<sup>th</sup> to 10<sup>th</sup> May, 2024 under the auspices of the Singapore-Colombo Plan Staff College Joint Training Program. The Government of Singapore will bear local hospitality (accommodation and local transfers), training fees, training allowance and group personal accident/hospitalization insurance. **The round-trip airfare for participants will have to be borne by the nominating Ministry/Division/Provincial Department.**

2. The eligibility criteria and objectives of the subject course are as under:

**Eligibility Criteria: -**

- Permanent Government Officers (BS-17 and above) and nominated by respective Federal Government or Provincial Department.
- Mid- to senior-level government officials who are involved TVET;
- Proficient in written and spoken English; and
- In good health.
- Prepared to participate actively in the programme.

**Objective: -**

- This course will introduce how Singapore TVET institutions formulate strategies and introduce innovative systems to enhance existing institutional management practices.
- It will also enhance participants understanding of application-based teaching and learning approaches, provide participants with strategy -identification tools to manage youth in TVET institutions and introduce skill sets required for jobs in the green economy.
