OFFICE MEMORANDUM

SUBJECT: - IN-PERSON COURSE ON "SUPPLY-CHAIN MANAGEMENT" TO BE CONDUCTED BY CIVIL SERVICE COLLEGE IN SINGAPORE FROM 12TH TO 16TH AUGUST, 2024, UNDER THE SINGAPORE PARTNERSHIP PROGRAMME TRAINING AWARD (SCPTA).

The undersigned is directed to inform that the Government of Singapore has invited **One (01)** nomination for the above **Partially Funded** training course. The Government of Singapore will bear local hospitality (accommodation and local transfers), training fees, training allowance and group personal accident/hospitalization insurance. **The round-trip airfare for participants will have to be borne by the nominating Ministry or Provincial Department.**

2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria:-

- Government employees (BS-17 and above) and nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials involved in waste management and sustainability;
- Nominated by their respective governments;
- Proficient in written and spoken English; and
- In good health.

Objective:-

- This course will discuss the future of supply chain management and share Singapore's approach in strengthening supply chain resilience.
