SUBJECT: - IN-PERSON COURSE ON "INTRODUCTION TO CARBON MARKET TO BE CONDUCTED BY SINGAPORE MANAGEMENT UNIVERSITY, EXECUTIVE DEVELOPMENT IN SINGAPORE FROM 22 TO 26 JULY, 2024, UNDER THE SINGAPORE PARTNERSHIP PROGRAMME TRAINING AWARD (SCPTA).

The undersigned is directed to inform that the Government of Singapore has invited **One (01)** nomination for the above **Partially Funded** training course. The Government of Singapore will bear local hospitality (accommodation and local transfers), training fees, training allowance and group personal accident/hospitalization insurance. **The round-trip airfare for participants will have to be borne by the nominating Ministry or Provincial Department.**

- Proficient in written and spoken English; and
- In good health.

- This in-person course is conducted under the auspices of the Singapore Cooperation Programme Training Award and is one of the courses offered under the Sustainability Action Package.
